I, as the undersigned parent or guardian of the Student named above acknowledge and agree to the following terms and conditions upon which this financial agreement is offered for the June and/or July 2012 Summer Preschool Program:

1. Tuition Obligation:

Parents promise to make full monthly tuition payments according to the following rates:

 *Unscheduled: \$60/day

*Unscheduled charges are for childcare attendance not scheduled in advance. Scheduled attendance for a specific month needs to be turned in to the school office by the third Tuesday of the month prior. (Example: Enrollment for August 2012 needs to be submitted by July 17th, 2012.)

**Students enrolled in a class will only be charged one half day rate on the days that they attend class.

2. Withdrawal Policy: All withdrawals must be in writing addressed to the Director. All payments due and paid up to the date of withdrawal are totally non-cancellable and non-refundable. All tuition payments are considered due and payable unless the Director has been informed of a withdrawal in writing prior to the next tuition due date.

3. Acceptance of this Agreement: This signed agreement, once signed by the director, will constitute a binding contract.

4. A non-refundable registration fee of \$15.00 per session is due at the time of registration.

5. Past Due Accounts: I acknowledge that if the student's account is past due, the Student may not be permitted to register for Summer Preschool. The School reserves the right to delay admission, suspend, or dismiss any student when the tuition account is past due at any time.

There will be \$25 charge for each returned check or denied electronic transfer of funds. Any time an account has an outstanding balance, the School reserves the right to withhold grade reports, transcripts, semester and final exams, as well as diplomas. The School shall have unconditional authority to suspend or terminate the student's participation in any or all school activities, at the school's sole discretion, at any time while the account described in this contract is not current.

6. Religious Instruction: The student's parent(s) or guardian(s) understand that all students in the School will be given instruction in the Christian religion according to the doctrine, discipline, and worship of the Lutheran Church Missouri Synod.

7. Responsibility for the Student: The student's parent(s) or guardian(s) assume full responsibility for the manner, safety, and protection of the Student in going to and from school and for the Student whenever on campus, except when s/he is involved in a school sponsored and supervised program.

8. Insurance: The student's parent(s) or guardian(s) expressly acknowledge that they are not named as an additional insured under any liability insurance policies issued to the School. If parents or guardians volunteer to transport or supervise school students, the insurance coverage, if any, for their actions or omissions will be provided solely by their own automobile insurance, homeowner insurance, or other liability insurance issued to them.

9. Conditions for Re-Enrollment: Completion of the current academic year in good academic and social standing is required for re-enrollment of current students. Student accounts must be paid in full prior to re-enrollment. If a re-enrollment offer is rescinded by the School after this agreement is executed, the School will refund the enrollment deposit.

10. Signatures, Collection, and Attorney's Fees: A parent or guardian who is responsible for tuition payment shall sign this Financial Agreement. In the event that it should be necessary to turn this Financial Agreement over to a collection agency and/or an attorney to enforce any of the terms hereof, the school's collection costs, expenses, and reasonable attorney's fees will be paid by the party executing this Financial Agreement for the Student.

11. Summary Statement: The terms and conditions of this Financial Agreement constitute the full and complete Agreement between the Parties. No other verbal or written Agreement shall, in any way, vary or alter any provision of this Financial Agreement unless both Parties consent to vary or alter any provision of this Financial Agreement in signed writing. This Financial Agreement is intended to be an integrated writing, and any prior oral or written Agreements between the Parties are merged into this Financial Agreement and extinguished. No custom or course of dealing between the Parties shall in any way vary or alter the terms and conditions of this Financial Agreement. If any provision of this Financial Agreement is invalid, illegal, or incapable of being enforced by reason of any rule of law, administrative order, judicial decision, or public policy, all other conditions and provisions shall remain in full force and effect.
