



RACE TEAM RELEASE AND INDEMNIFICATION

The undersigned Participant and Participant's parents/guardians understand and agree with the following:

- a. alpine skiing is an action sport carrying significant risk of serious personal injury, death and property damage, which risks are substantially increased by practicing for and actually participating in competitive ski racing, which is, at least in part, designed to test the limits of Participant's skill and control:
- b. natural, mechanical and environmental conditions and risks, independently or in combination with the Participant's activities, may cause property damage or severe or even fatal injuries to Participant or others:
- c. the Muskego Alpine Ski Team and the Muskego H.S. Ski Parents SHALL NOT BE RESPONSIBLE for controlling or supervising the activities of other skiers, participants or spectators or for protecting Participant's safety:
- d. PARTICIPANT AND PARENT(S)/GUARDIAN(S) SHALL BE SOLELY RESPONSIBLE FOR PROTECTING PARTICIPANT'S SAFETY, including (without limitation) use of appropriate head and other protective gear, before, during and after participation in any practice, race or other activity associated with the Muskego Alpine Ski Team or the Muskego H.S. Ski Parents AND AGREE TO ACCEPT ALL RESPONSIBILITY FOR THE RISKS, CONDITIONS AND HAZARDS WHICH MAY OCCUR, WHETHER KNOWN OR UNKNOWN.

PARTICIPANT IRREVOCABLY RELEASES AND DISCHARGES, in advance, the Muskego Alpine Ski Team and the Muskego H.S. Ski Parents from any liability whatsoever, know or unknown, for foreseen and unforeseen injuries and damages even though that liability may arise out of negligence or carelessness of the members of the Muskego Alpine Ski Team or the Muskego H.S. Parents or from the use, design or condition of any equipment or facilities utilized in conjunction with any such Event. PARTICIPANT AGREES to abide by and accept all rules and regulations of the Muskego Alpine Ski Team and the Muskego H.S. Parents relating to the sponsored events.

Each PARENT(S)/GUARDIAN(S) REPRESENTS AND WARRANTS to the Muskego Alpine Ski Team and the Muskego H.S. Ski Parents that the foregoing has been thoroughly explained to the Participant and that sufficient medical and accident insurance is and will continue to be maintained (throughout the entire period of Participant's participation in training and competition) to cover all costs of medical care and treatment required as a result of any injury of accident. Each PARENT AGREES TO INDEMNIFY AND HOLD HARMLESS the Muskego Alpine Ski Team and the Muskego H.S. Ski Parents from any and all liability sustained or incurred as a result of any injury or damage to or death of Participant arising prior to, during or after an Event as a result of any negligence of Participant or of any such Ski Organization, Member or any other participant.

I HAVE READ AND UNDERSTAND THAT BY SIGNING THIS DOCUMENT, I WILL FOREVER BE BARRED FROM BRING CLAIMS OR LAWSUITS FOR ANY BODILY INJURIES WHICH MAY BE CAUSED BY OR AGAINST THE MUSKEGO ALPINE SKI TEAM OR THE MUSKEGO H.S. SKI PARENTS.
